

Completion of \$6m Share Placement

The directors of Encounter Resources Ltd (“Encounter” or “the Company”) are pleased to announce the Company has completed the issue of 31,578,930 ordinary fully paid shares (“Shares”) to unrelated parties pursuant to the ~\$6 million share placement (“Placement”) advised to ASX on 23 October 2020.

The Placement has been completed pursuant to the Company’s 15% placement capacity under ASX Listing Rule 7.1.

The Company will seek approval at a general meeting of shareholders, to be held in early December, to allow Directors and related parties to participate in the Placement in the amount of \$300,000 on the same terms. The date of the proposed shareholder meeting will be advised in due course.

Euroz Hartleys acted as Lead Manager and Chieftain Securities Co-Manager to the Placement.

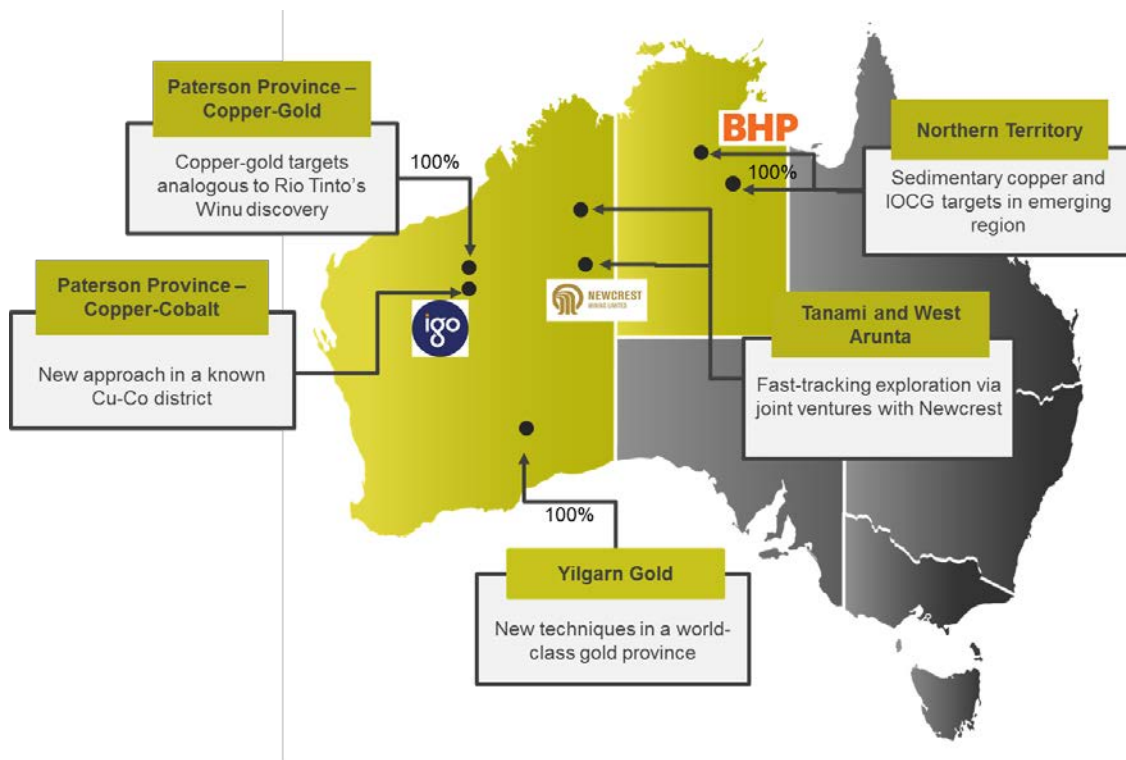

Encounter Resources Limited is one of the most productive project generation and active mineral exploration companies listed on the Australian Securities Exchange. Encounter's primary focus is on discovering major gold deposits in Western Australia's most prospective gold districts: the Tanami, the Paterson Province and the Yilgarn.

The Company is advancing a highly prospective suite of projects in the Tanami and West Arunta regions via joint ventures with Australia's largest gold miner, Newcrest Mining Limited (ASX:NCM).
